St. Croix County is releasing a bid for removal of the existing picnic pavilion and concrete base at the Glen Hills Park Picnic Area (1049 Rustic Rd 3), construction of a new large picnic shelter in the same location and construction of a small picnic shelter in the same vicinity as the large shelter. The bid will also include a small shelter at the Bass Lake boat landing property (733 153rd Ave). The shelters must be ordered as kits from Cedar Forest Products. Product number for the Large Shelter is OTT3044C and product number for the small shelter is MSW1418C. Bids must include all site work including all concrete work. A deduct for the (Chilton Weathered Edge with Red) stone columns on the Glen Hills Large Pavilion is also required. Contractor will be required to connect new electrical to existing at Glen Hills.
