**NOTICE OF COMMENCEMENT OF PROCEEDING *IN REM*
TO FORECLOSE TAX LIENS BY ST. CROIX COUNTY**

TAKE NOTICE that all persons having or claiming to have any right, title, or interest in or lien upon the real property described in the List of Tax Liens for 2025, Number 1, on file in the office of the Clerk of the Circuit Court of St. Croix County, dated June 3, 2025, and hereinafter set forth, are hereby notified that the filing of such List of Tax Liens in the office of the Clerk of Circuit Court of St. Croix County constitutes the commencement by said St. Croix County of a special proceeding in the Circuit Court for St. Croix County to foreclose the tax liens therein described by foreclosure proceeding *in rem* and that a notice of the pendency of such proceeding against each piece or parcel of land therein described was filed in the office of the Clerk of the Circuit Court on June 3, 2025. Such proceeding is brought against the real property herein described only and is to foreclose the tax liens described in such List. No personal judgment will be entered herein for such taxes, assessments, or other legal charges or any part thereof.

TAKE FURTHER NOTICE, that all persons having or claiming to have any right, title or interest in or lien upon the real property described in said List of Tax Liens are hereby notified that a date stamped copy of such List of Tax Liens has been posted in the Office of the County Treasurer of St. Croix County and will remain posted for public inspection up to and including August 15, 2025, which date is hereby fixed as the last day for redemption.

TAKE FURTHER NOTICE, that any person having or claiming to have any right, title or interest in or lien upon any such parcel, may on or before said August 15, 2025, redeem such delinquent tax liens by paying to the County Treasurer of St. Croix County, the amount of all such unpaid tax liens and in addition thereto, all interest and penalties, which have accrued on said unpaid tax lien, computed and including the date of redemption, plus the reasonable costs incurred to initiate the proceedings, plus the person's share of the reasonable costs of publication under Wis. Stat. § 75.521(6).





TO THE CIRCUIT COURT FOR ST. CROIX COUNTY WISCONSIN:

Now comes St. Croix County, by Denise Anderson, its County Treasurer, and by counsel, Heather M. Amos, for delinquent taxes as hereinafter alleges and shows to the Court:

1. A tax certificate has been issued to St. Croix County for unpaid taxes on each of the following described parcels of land, and three (3) or more years have elapsed since the dates of the tax certificates, such dates being the tax certificate year indicated on the List.
2. St. Croix County is now the owner and holder of tax liens for the years indicated on said List, as evidenced by the tax certificate numbers shown on the List.
3. St. Croix County has, by ordinance adopted by the County Board of Supervisors of said County on August 17, 2004, by Ordinance No. 666 (2004), elected to proceed under Wis. Stat. § 75.521, for the purpose of enforcing tax liens in said County.
4. Said List, made and filed pursuant to the provisions of Wis. Stat. § 75.521, is attached hereto and incorporated herein by reference.
5. Interest and penalty on the principal sum of each tax lien are charged from February 1 of the year of the tax certificate through the date of redemption.
6. Interest and penalty are charged at the rate of one and one-half percent per month.
7. All descriptions by lot and block number refer to plats and maps filed in the Office of the Register of Deeds for St. Croix County, Wisconsin.

8. The Town of Glenwood is a municipality having a right, title or interest in the proceeds from the sale of Item #3.
9. The Town of Hudson is a municipality having a right, title or interest in the proceeds from the sale of Item #4.
10. The Village of Roberts is a municipality having a right, title or interest in the proceeds from the sale of Item #9.
11. The Village of Somerset is a municipality having a right, title or interest in the proceeds from the sale of Item #10
12. The Village of Wilson is a municipality having a right, title or interest in the proceeds from the sale of Item #14.
13. The City of Glenwood City is a municipality having a right, title or interest in the proceeds from the sale of Items #20.
14. The City of New Richmond is a municipality having a right, title or interest in the proceeds from the sale of Item #22.
15. The United States of America may claim some interest in or lien on the following parcels of real property subject to this foreclosure proceeding:
